

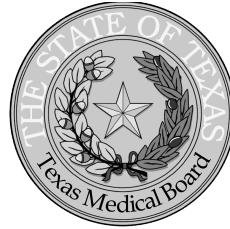


TEXAS MEDICAL BOARD

A Non-profit Charitable Health Center is a non-profit corporation under the Texas Non-Profit Corporation Act (Article 1396-1.01 et seq., Vernon's Texas Civil Statutes) and Section 501(c)(3), Internal Revenue Code of 1986 (26 U.S.C. Sec. 501(c)(3)); and is organized and operated as either; (A) a migrant, community, or homeless health center under the authority of and in compliance with 42 U.S.C. Section 254b or 254c; or (B) a federally qualified health center under 42 U.S.C. Section 1396d(l)(2)(B).

Each charitable health center certified under Texas Occupations Code Section 162.001(c) is considered active until verification with the Secretary of State documents the entity is no longer in existence or request for cancellation has been received from the entity.
