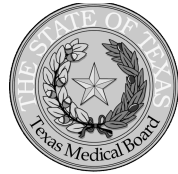

TEXAS MEDICAL BOARD

Organizations that are nonprofit corporation under the Texas Business Organziations Code, Chapter 22, Sec. 22.0561. are organized to: (A) conduct scientific research and research projects in the public interest in the field of medical science, medical economics, public health, sociology, or a related area; (B) support medical education in medical schools through grants and scholarships; (C) improve and develop the capabilities of individuals and institutions studying, teaching, and practicing medicine; (D) deliver health care to the public; or (E) instruct the general public in medical science, public health, and hygiene and provide related instruction useful to individuals and beneficial to the community; that are organized and incorporated solely by persons licensed by the board; and that have as their directors and trustees persons who are: (A) licensed by the board; and (B) actively engaged in the practice of medicine.

Each health organization certified under Section 162.001(b) shall file with the board a biennial report in September of each odd-numbered year if the organization was certified in an odd-numbered year or in September of each even-numbered year if the organization was certified in an even-numbered year.
